



Waiver and Release

The NAHS Pup Rally is intended to be a fun, rewarding experience for all participants, and we hold their safety in high regard. We continually strive to reduce risk and insist that all participants and their owners follow the safety rules and instructions that are designed to protect them. Persons who allow their puppies to participate in the Pup Rally must understand there are inherent risks of injury associated with this type of activity.

You are responsible for determining if your puppy is appropriate for this activity. We will not allow animals displaying aggressive behavior to participate in the Pup Rally, and we reserve the right to determine if a dog is in appropriate for the Rally.

Please read this agreement carefully and be aware that in registering for the Pup Rally, you will be assuming the risk of injury or damage to yourself, your pet, and your personal property. You are releasing Naperville Area Humane Society from all liability and claims for injury, damage to property and all other damage you, your children, and your dog(s) might incur as a result of your Pup Rally participation. Each person who enrolls a puppy in the Pup Rally does so at his/her own risk.

Agreement to Waiver and Release of all Claims and Assumption of Risk

In consideration of Naperville Area Humane Society allowing me to enroll my puppy in the Pup Rally, I agree on behalf of myself as follows:

I recognize and acknowledge that there are risks to myself, minors in my care, and my dog(s) of injury and other damage as a result of participation in Pup Rally. On behalf of myself, and as parent or guardian of minors in my care, I voluntarily agree to assume the full risk of any and all such injuries and damages, regardless of how serious, that I and my dogs might sustain on the Naperville Area Humane Society premises. I further agree to waive and relinquish all claims for such injury or damage that I, minors in my care, or my dog(s) may have now, and at any time in the future against Naperville Area Humane Society, its employees, volunteers, board members, financial supporters, officers, representatives, assigns, agents, attorneys, and all others who might be claimed to be liable on its behalf, as a result of participation in the Pup Rally.

On behalf of myself, as parent or guardian of minors in my care, and my dog(s), I do hereby fully release and forever discharge Naperville Area Humane Society, its employees, volunteers, board members, financial supporters, officers, representatives, assigns, agents, attorneys, and all others who might be claimed to be liable on its behalf, from any and all liability, claims, demands, and causes of action for injuries to myself, minors in my care, or my dog(s), damage to
